

INTRODUCTION and EXPLANATION

I am enclosing the attachment, “*An Explanatory Memorandum* (hereinafter call the “Memorandum”). Through this document, I can prove that there is a plan of the Muslim Brotherhood to make the United States an Islamic nation. The Memorandum was admitted into evidence in a criminal trial prosecuted by the United States Justice Department in a Federal Court in Dallas, Texas, commonly known as the Holy Land Foundation Trial, one of the most important trials in American history. I believe that document is one of the most important documents discovered because it is a Muslim Brotherhood (“MB”) document describing its Plan to make the U.S. a Muslim country. If you want to learn more about the trial, I will be glad to discuss that subject with you.

IN A MUST READ, Frank Gaffney gives a great narrative of how the Memorandum was discovered and its contents:

INTRODUCTION

In August of 2004, an alert Maryland Transportation Authority Police officer observed a woman wearing traditional Islamic garb videotaping the support structures of the Chesapeake Bay Bridge, and conducted a traffic stop. The driver of the vehicle was identified as Ismail Elbarasse and detained on an outstanding material witness warrant issued in Chicago, Illinois, in connection with fundraising for Hamas.

The FBI’s Washington Field Office subsequently executed a search warrant on Elbarasse’s residence in Annandale, Virginia. In the basement of his home, a hidden sub-basement was found. The contents of the sub-basement proved to be the archives of the Muslim Brotherhood in North America. Among the 80 banker-boxes worth of documents discovered there were papers that confirmed what investigators and counterterrorism experts had long suspected and contended about the myriad Muslim-American groups in the United States: nearly all of them are controlled by the Muslim Brotherhood.

Therefore, in accordance with the supremacist Islamic doctrine known as shariah, such groups are hostile to this country, its Constitution and freedoms. The documents make clear the groups’ sole objectives are to implement Islamic law in America in furtherance of re-establishing the global caliphate.

One of the most important of these documents made public to date was entered into evidence during the Holy Land Foundation trial. It amounted to the Muslim Brotherhood's strategic plan for the United States and was entitled, "An Explanatory Memorandum: On the General Strategic Goal for the Group in North America." The Explanatory Memorandum was written in 1991 by a member of the Board of Directors for the Muslim Brotherhood in North America and senior Hamas leader named Mohamed Akram. It had been approved by the Brotherhood's Shura Council and Organizational Conference and was meant for internal review by the Brothers' leadership in Egypt. It was certainly not intended for public consumption, particularly in the targeted society: the United States.

For these reasons, the memo constitutes a kind of Rosetta stone for the Muslim Brotherhood, its goals, modus operandi and infrastructure in America. **It is arguably the single most important vehicle for understanding a secretive organization and should, therefore, be considered required reading for policy-makers and the public, alike.**

Among those warranting special attention are what amounts to the mission statement of the Muslim Brotherhood in America: The process of settlement is a "Civilization-Jihadist Process" with all the word means. The Ikhwan [Arabic for Muslim Brotherhood] must understand that their work in America is a kind of grand jihad in eliminating and destroying the Western civilization from within and "sabotaging" its miserable house by their hands and the hands of the believers so that it is eliminated and God's religion is made victorious over all other religions.

As Team B II observed:

In other words, the Ikhwan's strategy for destroying the United States is to get us, specifically our leadership, to do the Muslim Brotherhood's bidding. The Ikhwan intends to conduct civilization jihad by coopting our leadership into believing a counterfactual understanding of Islam and the nature of the Muslim

Brotherhood, thereby manipulating or coercing these leaders to enforce the MB narrative on their subordinates.

Another extraordinarily important element of the Memorandum is its attachment. Under the heading “A List of Our Organizations and Organizations of Our Friends,” Akram helpfully identified 29 groups as Muslim Brotherhood fronts. Many of them are even now, some twenty-two years later, still among the most prominent Muslim-American organizations in the United States.

Worryingly, the senior representatives of these groups are routinely identified by U.S. officials as “leaders” of the Muslim community in this country, to be treated as “partners” in “countering violent extremism” and other outreach initiatives. Obviously, this list suggests such treatment translates into vehicles for deep penetration of the American government and civil society.

We urge the readers of this pamphlet to share it with others—family members, friends, business associates and most especially those in a position to help adopt policies that will secure our country against the threat posed by shariah and its most effective and aggressive promoters, the Muslim Brotherhood.

EXPLANATION

The Muslim Brotherhood has a Plan how our country will become a Muslim nation under Sharia as part of the goal of establishing global Islamic state. The Muslim population in the U.S. is growing rapidly as a “process of settlement.” The MB’s plan is to “infiltrate” Muslims into our society, appearing to be assimilating as Americans while the real purpose is to capture positions of power using the rights granted under our Constitution and laws. Between using our Constitution, our laws and the naive welcoming Americans, the MB is working to create an Islamic nation.

“An Explanatory Memorandum” is a document prepared by the MB detailing its Plan. The first half is in Arabic followed by the English translation. Take a look at the cover page. It shows that the document was marked as an Exhibit in the Holy Land Foundation trial.

Now go to Paragraph 4 on page 7 of 18 in the English section. There you will find the key language showing the heart of the plan of the MB (you should also look at the last page to see the “co-conspirator Muslim organizations” at that time - some are no longer in existence- others have been born). Here is the key language in the Memorandum:

"The process of settlement is a "Civilization-Jihadist Process" with all the word means. The Ikhwan must understand that their work in America is a kind of grand Jihad in eliminating and destroying the Western civilization from within and ‘sabotaging’ its miserable house by their hands and the hands of the believers so that it is eliminated and God's religion is made victorious over all other religions." (my emphasis)

“Ikhwan” is the Muslim Brotherhood.

Under the Plan of the Muslim Brotherhood, the "Islamic center" (which is a mosque) is the focal point as described on Page 11 of 18 beginning on the third line from the top":

Thus, the Islamic center would turn into a place for study, family, **battalion**, course, seminar, visit, sport, school, social club, women gathering, kindergarten for male and female youngsters, the office of the domestic political resolution, and the center for distributing our newspapers, magazines, books and our audio and visual tapes.

Note that I emphasized “battalion” because *civilization jihad* could become violent. If you understand Islam, you understand that Muslims are commanded to emulate Mohammed. Mohammed used mosques for multiple purposes, including for storage of weapons and as a center for military planning and execution for violent jihad.

The Muslim Brotherhood Plan requires for each city to have an “Islamic center” as shown on the last three lines at the bottom of Page 12 of 18:

This does not prevent - but calls for — each central organization to have its local branches but its connection with the **Islamic center in the city is a must**.

FURTHER EXPLANATIONS

“Jihad” is demanded of Muslims. What is jihad? The fundamental purpose of jihad is to spread Islam throughout the world. Most people associate Jihad with violence. However, the reality is that jihad can be accomplished through a peaceful

process. And in the United States today, a successful plan of violent Jihad would fail. That is why the Muslim Brotherhood designed the Plan described in the *Memorandum*.

A peaceful concept of jihad is “Civilization Jihad” wherein there is a settlement of Muslims into a geographic area with the aim of an ultimate takeover with the imposition of Sharia are the goals. It is also happening in Europe, especially in England, France, The Netherlands and other European nations with “no-go zones” where the police do not attempt to enforce the law of the nation while Muslims have set up their own governance under Sharia.

As the Memorandum describes, the Jihadis will use our own rights enumerated in our Constitution and take advantage of our welcoming culture to destroy the U.S. It has happened in Dearborn, Michigan, Hamtramck, Michigan, and Paterson, New Jersey, and evolving in other areas in our country. EPIC City near Josephine is a target along with at least seven other sites in Collin County that we know of (St. Paul, Plano, Celeste, Blue Ridge, Sachse, Wylie, and Murphy) as well as Aubrey in Denton County. There are over 400 mosques in Texas. **YOU ARE WITNESSING THE MUSLIM BROTHERHOOD PLAN IN ACTION AS DESCRIBED IN THE MEMORANDUM.** Once the Muslims establish a significant presence in a community, the surrounding neighborhoods begin to lose value and the Muslims purchase those homes at bargain prices.

Once the Muslim population reaches a certain level, they will commence voting in large numbers, fielding their own candidates and using their vote to ultimately attempt to impose Sharia on city governments. The Muslims will elect county officials, state representatives and state senators. In the meantime, there will be elections of members of Congress. Over the years, the final goal is to take down our nation and impose Sharia.
